Presentation and Discussion Guidelines

As has happened so successfully at previous TMN meetings, all TMN members attending the meeting are encouraged to present on their company's practices/ lessons learnt relating to the meeting topics.

This TMN meeting will focus on "R&D Centre Management, including R&D Project Valuation and KPIs".

Each member will have approximately 45 minutes to present and discuss questions. Please come with some PowerPoint slides for your presentation. Based on the topic, the bullets below include some ideas to pick from.

R&D Centre Management, including R&D Project Valuation and KPIs

- How does your company set R&D objectives (e.g. imposed by BUs, suggested by R&D, set collaboratively)
- To what extent does corporate HQ direct the R&D centre's activities?
- Are R&D projects selected in isolation (i.e. the program is the sum of individual yes/no decisions about potential projects, or is the selection process portfolio-driven? If the latter, how do you use portfolio techniques to select an optimum set of R&D projects?
- How is your R&D funded (by whom, and who decides how much)?
- How does the R&D centre report a return on the investment made into it?
- What KPIs do you use to measure the effectiveness of your R&D departments? How are these developed, measured and reported on?
- How are R&D centre staffing decisions made? And by whom?
- Is a position at the R&D centre perceived as a desirable posting? What effect does it have on someone's career?
- What valuation methodologies do you use for your R&D projects? How do these vary by project type/size?
- What value do you see in evaluating R&D projects?
- How do you compare/decide about projects with very different types of 'value' (e.g. drilling cost reduction vs HSSE)?
- To what extent do different parts of the business believe the valuations placed on R&D projects?
- What KPIs do you use to measure the probability of success of an R&D project? How is the measurement of commercial risk different to that of technical risk, if at all?
- How do the KPIs / valuations of individual R&D projects relate to those of the centre as a whole?
